SB09-024	Makes several changes to laws governing how the Division of Wildlife (DOW) responds to landowners' claims of wildlife damage, including making it easier for a landowner to obtain a "kill permit" for wildlife. Provides an incentive for landowners to allow hunting on their property. An amendment added by the House Agriculture Committee would have mandated that the DOW issue kill permits when wildlife damage is "excessive." (This amendment was removed from the final version of the bill.)		Yes (this vote was to repass the bill after House changes)	No	Signed into law
SB09-118	Re-authorizes the "Pet Animal Care and Facilities Act" (PACFA), a licensing and inspection program for various facilities that house or handle "pet" animals. Raises facility license fees by a sufficient amount to hire an additional PACFA inspector. Adds rats and gerbils to the definition of "pet" animal. Requires licensed facilities to publicly post the contact information for the department that enforces PACFA. Expands the PACFA advisory committee to include a representative from the dog daycare industry. Changes the next sunset review date for the act to 2014. SJR09-048	Resolves that the Colorado General Assembly supports the protection and restoration of Colorado's shortgrass prairie ecosystem.		Yes	Yes	Passed in Senate; never voted on by House

Note: Senator Tapia was the Senate sponsor of House bill 1095 (HB09-1095), a CHVL-opposed bill, which would have encouraged the resumption of live dog racing in Colorado, by reducing the state tax on pari-mutuel wagering on greyhound racing from 4.5% to 0.75%. The bill also would have increased the number of simulcast days allowed per year from 250 to 360. HB09-1095 was killed by the House Finance Committee.
